CALL TO ORDER

In the absence of President Lisa Withers, the meeting was called to order by President-elect Gabriella Ryan at 8:15 am.

The minutes of the June 11, 2011 teleconference as printed in *NewsNotes*, with the correction the Belinda Stevens was nominated as Secretary-elect, were approved.

REPORTS

President Lisa Withers reported that we have agreed to sell our Theory Syllabus to Christine Hermanson for \$50. Tonya

Menard, VMTA Theory Chair, wondered if we should copyright it and earn royalties, since it is sought after. No decision on that.

President-elect Gabriella Ryan reported an attendance of 100 members and enthusiastic reception of the opening concert and the Ann Schein recital the previous evening.

Membership Chair Denise Adkins reported that we have 838 members as of Sept. 30 (670 actives, 145 seniors, 23 students).

Treasurer Tracy Cowden reported a balance of \$43,000 in checking and savings accounts. Certificates of Deposit are earning very low interest and those funds will be moved to a Money Market Account as they come due for renewal.

Certification Chair Martha Smith reported that the new certification procedure requiring videos of 3 stages of teaching a piece has proved problematic for some applicants, but expects that members will gradually get used to it. She advised new applicants to read the instructions very carefully. Paolo Steinberg, the nominee for President-Elect, has applied for certification by administrative verification.

Chair of Local Associations Galla Matekova reported that 13 representatives from the 12 Local Associations met yesterday and had a vigorous exchange of ideas.

Chair of IMTF Samantha Luck reported good attendance at the IMTF session the previous afternoon. She intends to set up a database of program ideas and presenters for all to share and invites submissions.

BUSINESS

1. After a wide-ranging discussion of the decision last July of the MTNA Board of Directors to discontinue non-piano competitions in 2013, the following Resolution was passed with 27 votes in favor, 0 against and 2 abstentions:

Resolved: The Virginia Music Teachers Association is in favor of supporting and maintaining MTNA competitions for non-pianists, specifically brass, woodwinds, strings and voice in 2013 and beyond.

This resolution will be sent to the MTNA Board prior to their December 1 meeting.

- 2. Gabriella asked for suggestions for filling two vacancies, the **Advertising Chair** and the **Chair of Local Associations**.
- 3. Theory Chairperson Tonya Menard presented the case for adding 20th Century techniques to the VMTA Theory Tests. Of 50 states, 33 give theory tests, but only 6 include 20th century materials. The Board voted unanimously in approval.
- 4. Sharon Stewart, Chair of the VMTA Nominating Committee, presented a slate of officers for 2011-13:

President – Gabriella Ryan, Richmond President-elect – Paolo Steinberg, Harrisonburg

Vice-President, Membership – Denise Adkins, Northern Virginia

Secretary – Belinda Stevens, Northern Virginia

Treasurer – Mun Lee Han, Tidewater Music Teachers Forum

Other members of the committee were Lise Keiter and Martha Smith. There were no nominations from the floor. These officers were elected unanimously and will take office December 1, 2011


ANNOUNCEMENTS

Certification Profile: Lisa Moxley

Virginia has a new Certification Chairman, Lisa Moxley of Bluefield. An adjunct faculty member of Bluefield College, Lisa Moxley teaches piano and ear training there and accompanies a choral group. She also has eight piano students in the community, including two sets of twins from the same family.

In 2008 Lisa and her husband Bryant Moxley, the Chairman of Bluefield's Music Department, were invited to speak at the Fall VMTA Conference. In their program on developing the church keyboard musician they discussed ways to involve children in music ministry, encouraging them to play preludes and gradually progress into a greater role in the music ministry, with the ultimate goal of developing church music professionals for the future.

After the presentation, Lisa ran into Martha Smith, then the Certification Chairman, and Martha asked her if she'd considered certification. Her curiosity was piqued. After giving it some thought she decided that being nationally certified would show students, parents, prospective students and other professionals that she had been endorsed in her field beyond the fact that she had the music degrees and years of experience. "I had already taught for 26 years. This would show that I was still pursuing excellence and not just content with what I had done in the past. It was really a motivator to know that VMTA would provide a \$100 rebate towards the cost of becoming certified." Lisa completed her application and became certified in 2009.

Lisa Moxley's undergraduate degree in music education and church music was earned at Ouachita Baptist University in Arkansas. At Southern Baptist Theological Seminary in Louisville, Kentucky, she earned a master's degree under Dr. Maurice Hinson, with emphasis on piano and music education. She started teaching while a senior in college. "I try to meet students where they are and take them as far as I can for as long as I can. I want to step out of my comfort zone and try different musical styles if that's what it takes to motivate the students."

A charter member of Blue Ridge Music Teachers Association, Lisa Moxley has served her local chapter as Vice-President and President. In her new role as VMTA Certification Chairman she encourages other VMTA members to make certification a professional goal for 2012. Only 12–13% of VMTA members are nationally certified. "We can do better. The process will improve your teaching."

YOU DESERVE "EXTRA CREDIT" FOR BEING A PROFESSIONAL!

There are times in my classes when I hear "Mrs. Moxley, is there any way I could do some 'extra credit' work?" This request usually comes after a sudden malady of impending doom regarding final grades. While it is not my usual practice to offer extra credit, I made an exception this past semester. This particular student had attended class faithfully, worked consistently outside of class, and displayed a sincere desire to develop the necessary skills to succeed in the class and now had the motivation to go beyond minimum class requirements to improve his grade. After some thought, I offered the class the opportunity to earn extra credit by studying for the final exam with the music department's tutor. Over 80% of the class accepted the offer, enabling the students to improve their scores on the final exam and end the semester on a more positive note.

Do you ever feel like that student- faithfully preparing and teaching each "class" to the best of your ability, desiring to help each student develop the necessary skills to succeed in music (and in life), and still feeling as if you could use some "extra credit" opportunities to improve your professional standing?

The process of becoming a Nationally Certified Teacher of Music is much like that extra credit work for my student. Although you are already doing many things to be considered a professional in the field of music such as lesson planning, performing, preparing students for recitals and competitions, manag-

ing a successful studio, participating in local chapter and VMTA events, attending conferences, learning new trends in music pedagogy and networking with other professionals, you may find yourself desiring some much-needed credit for your efforts and even some "extra credit" opportunities for improving your teaching and professional standing. The MTNA Professional Certification Program could be just the "extra credit" opportunity you need to reach your professional goals for 2012 and beyond.

There is much more specific information to be obtained from the MTNA website at http://www.mtnacertification.org/, but the following excerpt provides an overview of the purpose and importance of certification:

"The MTNA Professional Certification Program exists to improve the level of professionalism within the field of music teaching. Conference: Oct. 27–30, 2011, Virginia Commonwealth University, Ann Schein, guest artist

Conference Highlights:

We doubled our attendance at our annual conferences the past 2 years by increasing our email advertising to monthly reminders, and by allowing registration by email and PayPal. This has made our conferences less costly, and we have nearly broken even these past 2 years! We began our conference these past 2 years with an Opening Ceremonies Member Recital, including flowers and balloons. This has been extremely well received. Our theme, "The Art and Science of Teaching Music," was developed in sessions about musical imagery, memorization, brain processing, contemporary music, overtones, and technique. We also had an optional excursion to the Virginia Museum of Fine Arts, in which a docent led us to artwork related to music. Ann Schein, our guest artist, and a student of Artur Rubinstein, was a great performer and master class clinician! She was definitely the highlight of our conference!

Activities and Accomplishments: We have updated our website to make it more user-friendly and visually stimulating, and have placed our yearbook and newsletter online. We will begin giving members the option of receiving these online rather than with paper copies to reduce our expenses. We have also begun having our Spring Conference by teleconference.

Awards and Recognitions: Anne James, NCTM, is our nominated MTNA Foundation Fellow, and will be recognized in March at the MTNA Conference. Allison Dettmer, flutist, student of Jennifer Lapple, placed 3rd in the MTNA National Junior Woodwinds Competition.

Newsletter and Communication: We send *NewsNotes* to all of our membership twice yearly, and communicate regularly by email. We will soon send this mostly by email.

Local Association Information: Virginia has 12 local associations, the largest of which is Northern Virginia. Other large associations are Richmond, Tidewater and Charlottesville. Many collaborative recitals were held last year. Local Chapters also held workshops given by Manahem Pressler, Melody Bober, Suzanne Guy, Gayle Kowalchyk, Nancy Breth, and Ann Schein. Over 1,000 students participated in music festivals and performances.

Additional Information: We are currently in the process of updating our Theory Testing to include contemporary techniques. One of our members worked with MTNA to poll other states to see if this was included in their theory testing. The results were that very few states included techniques used in music composition beyond 1900! Virginia will be one of the leaders in this regard. We'll keep MTNA informed of the progress we're making.

The Woodwinds Competition, held Friday, October 28, was judged by Kelly Sulick (flute) of the University of Virginia, Michael McDonald (clarinet) of the Navy Band, and Nick Hecker (clarinet/saxophone) of the Virginia Symphony. The Piano Competition, held Friday, October 28, was judged by Nicholas Ross of Sweet Briar College, John Mayhood of the University of Virginia, and Anna Kijanowska of the College of William and Mary. Five students participated. The results are: Winner: Jasmin Lee, student of Bradford Gowen. Alternate: Ednaldo Borba, student of Paulo Steinberg.

All Winners proceed to the Southern Division Competition at Mississippi College in January 2012.

Additionally, the state of Virginia will send a Representative in the Chamber Music category in the Southern Division Competition. The Graduate Wind Trio of Benjamin Peck (bassoon), Eugene Sidorov (oboe), and Eric Waggoner (piano) are students of Ryan Romaine.


I'm looking forward to an exceptional year with MTNA, VMTA, and all the local Associations! ■

VMTA 2011 FALL CONFERENCE SURVEY RESULTS

This year the conference survey was sent by email, using surveymon-key.com. There were still few responses (24 out of 100 attendees), but this is twice as many responses as were usually received from paper surveys. Studies show that surveys generally net about 10% responses, so 24% is an acceptable rate of results.

A summary of the results of this questionnaire follows:

1. What were your main reasons for attending?

The biggest responses were workshops and new ideas. Next came networking and Ann Schein. Other reasons were competitions and colleagues' performances.

2. Would you like to continue the Opening Ceremonies Recital?

92.9% said yes, they'd like to see this event continued. There were several comments that said they wished it had been more well-attended.

3. What did you like best?

The workshops and Ann Schein received the most votes on this question. Competitions and the early business meeting were the next mentioned items. Other items included the art museum, networking, and the opening ceremonies recital.

4. What could have been improved?

The most votes were given to campus parking. Next came the suggestion to publish the details of each competition. There was also a list of other differing items, but each was only given by one vote, so they would be statistically invalid.
