At 9:10 Gabriella Ryan called the meeting to order.

The agenda was approved after some minor adjustments. Minutes were approved after the corrections of some misspelled names.

New members and student members were introduced and welcomed.

Gabriella Ryan shared her learning experiences from the MTNA conference. The next MTNA conference will convene in Chicago on March 22–26, 2014. Gabriella announced that the VMTA presidents' summit is new this year and will take place at JMU on October 26. The new advertising chair is Samantha Luck. The commissioned composer chair, David Schaffer-Gottschaulk has resigned because of a move. Denise Adkins is resigning as membership chair and will be replaced by Rebecca Wallenborn.

Paulo Steinberg reported that 70 members had registered for the conference with 12 of them being collegiate students. He felt that the response to the change of venue for the conference had been mostly favorable. One suggestion given was to advertise in advance. The MTNA Competitions and VMTA auditions will take place at JMU on October 24–26. On October 25, there will be a handbell choir session with Kath Winninger. A summit for local chapter presidents will take place on October 26. The next conference will take place at Wintergreen on July 17–20.

Mun Lee Han reported \$18,412.01 in checking, \$22,012.73 in savings and \$4,238.34 in CD's. The bulk mail permit is being closed. After discussion on the proposed budget, the move to approve it was made, seconded, and voted on.

As representative of the certification

committee, Sharon Stewart, presented certification pins to the newest certified members, Gabriella Ryan and Paulo Steinberg.

Local association chair, Donna Halleck reported that 8 chapters were represented at the presidents' luncheon and each shared what each chapter is doing.

OLD BUSINESS

The theory committee has made two rule changes. 1. A student may take only one test per year. 2. A failed test does not have to be retaken in order for a student to advance to the next level.

There is an advertising budget for local associations. VMTA will match up to \$250 in advertising when MTNA or VMTA is mentioned.

VMTA did not receive the state grant for which we applied to help with conference expenses. There were many entries, but it appears what hindered us from receiving the grant was that VMTA shows a profit and only 10% of the membership attend the conference.

NEW BUSINESS

VMTA is replacing our old code of ethics with the new policy of MTNA. All chapters have received this information by e-mail.

The membership discussed, voted, and passed the Committee's recommendation to change the bylaws regarding student membership to read, "Student membership is open to all full-time college students currently involved in music study. Student members may attend all programs of the Association and will receive the Association publications. Student members shall not have the right to vote or hold office, but may enter students into competitions or other events of the association."

After discussion, the membership voted and passed the Committee's recommendation that "Any VMTA event will be open to nonmembers for an additional fee. Each student will pay the entry fee plus an additional \$25 charge."

The membership discussed, amended, and passed the Committee's recommendation as follows:

"Advertisers who are selling products and wish to e-mail VMTA members will be charged \$25 for VMTA member advertisers and \$125 for non-member advertisers per distribution. Advertisers will not receive email addresses. VMTA will distribute their ad electronically."

A proposal was made to have an online vote to change the bylaws to include voting rights for student members. This was tabled for a future time. Gabriella announced that Betty Ann Spiers would serve as the new bylaws chair.

The nomination committee consisting of Paulo Steinberg, Susan Atkins, and Kim Peachy presented the new slate of officers:

The motion to approve the nominations was seconded and the membership voted in the new officers.

VMTA THEORY TESTS

Tonya Menard, NCTM, VMTA Theory Chair

Hello Virginia Teachers,

Certainly, you are all awaiting the updates to the state theory tests. Well, the sample tests are online! Thanks to Peter Curry, our hired computer connoisseur, and our newly expanded theory committee, we are up and running! The theory committee consists of Roma Scriven, Fay Barss, Hope Armstrong-Erb, Sam Wellman, Peter Curry, and myself with much assistance from our president, Gabriella Ryan. We have all worked many hours to bring you these updates and we believe you will be pleased with the results.

Please take some time to download the new sample tests and syllabus from the VMTA website and throw the old ones out. They will not help you with the exam for this year. Levels Primer through 2B do not contain any syllabus updates—only corrections to mistakes we have found. Levels 3A through 12 all have updates and the students will have great fun learning the interesting 20th-century concepts that are now included. In addition to the 20th-century items, there are also some more "classical" theory concepts that were asked for and inserted.

There is a NEW RULE. Students may only take ONE TEST PER YEAR. If a student did not pass a level the previous year, they do not need to re-take that test (although it would be wise for them to pass the sample test in your own studio before skipping levels). If a student has excelled in theory and wishes to skip levels from one year to the next—they may do so. If you have a transfer student, they may enter the testing at whatever level is appropriate. Although this may slightly lower the income made from the fee of the exams, it will greatly improve the testing and grading time. I wish to recognize that there has been anxiety from some teachers about changing the exams. The committee has worked very hard at making the definitions, listening examples, analysis questions, and fill in the answer questions very clear for the student and teacher. The answer keys will help you and we are providing a student-friendly glossary of new terms on the VMTA website.

Also to assist you in making this adjustment, Roma Scriven has agreed to share her 20th-century student repertoire list with VMTA teachers. It will be available on the website as a resource you can use with your students to study the concepts within pieces of music. I have also made myself available to come to the local chapters and do informational workshops in the fall for teachers who could not attend the state conference.

We have done our best to find mistakes in the answer keys and fix them. The goal was zero mistakes. However, none of us are perfect and although the tests have had at least 6 sets of eyes on them, it is possible for some things to have slipped through the cracks. We welcome your corrections and will try to accommodate them for next year. In addition, if you do not have access to a computer and cannot download the materials, please ask your local chairperson for a paper copy. Costs for copying tests can still be turned in for reimbursement, but paper copies will no longer be mailed out to local chairpersons.

If you have questions after you have seen the materials you may email me at menardtm@dukes.jmu.edu and I will do my best to answer you quickly. The committee and I thank you for your patience and for your help in making this transition a positive and fun experience for your students. I truly believe your studios will buzz with a newfound energy as you introduce these new (but 100-year-old) concepts to your students. ■

Certification Profile: Linda Gutterman

Galways knew certification was a good idea. I was thinking I should do it for years and years. It was just getting over the inertia." In 2010 Arlington piano teacher Linda Gutterman fulfilled that ambition, with the encouragement of NVMTA Certification Chair Diane Perett. "I had to write a lot about my philosophy of teaching. I submitted eight

weeks of lesson plans for a particular student, a DVD of a senior recital by one of my students, and did a lot of writing, which I found very valuable. It forces you to think about what you are doing and how you do it. It has helped solidify my ideas about my purpose and my philosophy."

Gutterman has a lot of young students. Her clientele of about twenty includes many boys, a fact she laughingly attributes to the basketball hoop in the driveway. Her youngest student is five. Her oldest, a 17-year-old who began with her at age four, hopes to be a composition major in college. Working mostly on his own, he wrote a three-movement symphony for his high school orchestra to perform.

Primarily a Suzuki teacher since 1983, Gutterman believes its early emphasis on training the ear contributes much to her

students' musicality. She also loves having the parent attending the lessons and assisting with practice. She modifies the method somewhat in teaching sightreading earlier. "I believe very strongly that if a child is given the right environment they can learn to play very well. The right environment includes a positive teacher, a supportive parent and a child who is willing to work."

"One thing I really enjoy doing is taking students to professional concerts. I want to motivate them. Hearing beautiful music beautifully played is a great motivator. I like to work with my students on their artistry right away. Whether they're telling a story or revealing an emotion I want to build musicality right from the beginning."

Linda Gutterman received a Bachelor's degree in Zoology from the University of Massachusetts and taught biology in high school for two years. Her Master's degree in music was earned at the University of Tennessee under William Dorn, who had studied with Adele Marcus. After moving to Virginia in 1980 she joined NVMTA. She has served that organization as Corresponding Secretary, Recording Secretary, chair of various events, recital adjudicator, and most recently, Board Member at Large.

CERTIFICATION

Lisa Moxley, NCTM, VMTA Certification Chairperson

MTA ended the 2012–2013 year with 874 members, 109 of whom are certified. This ranks VMTA as 32nd (tied with Texas) among MTNA state affiliates with 12.5% of our membership certified. There were 3 new certifications during the year—Julie Hahn, Bryant Moxley and Gabriella Ryan.

At the 2013 summer conference, VMTA recognized Blue Ridge and Shenandoah chapters for highest percentage of certified members in a small chapter with 50% each. Central Virginia and Tidewater chapters were recognized for highest percentage of certified members in a large chapter with 22% each. Congratulations to these chapters!

Other chapters' percentages are as follows:

Small Chapters (less than 20): HIGHL 3 certified of 12 members = 25% PIED 2 certified of 6 members = 33% PMTA 1 certified of 4 members = 25% HMTA 2 certified of 11 members = 18%

Large Chapters (20 or more): CMTA 3 certified of 78 members = 4% NVMTA 44 certified of 417 members = 11% RMTA 15 certified of 80 members = 19% RVMTA 6 certified of 44 members = 14% VMTA would like to encourage each chapter to work toward increasing its number of certified members this year. Is your chapter president certified? If not, his/her work toward certification would be a great example for other chapter members. Are there full-time or part-time college faculty in your chapter? Remind them that their process is relatively simple and encourage them to complete the paperwork. Perhaps your chapter would like to follow Blue Ridge's example and offer a rebate of \$25 or more in addition to the VMTA rebate to show your support for those seeking certification. Remember that VMTA provides a <u>\$100 rebate</u> to members completing certification. **Chapters increasing their certification numbers will be recognized at next year's VMTA conference and the chapter with the largest percentage increase will receive special recognition!**

COMPOSITION COMPETITION REPORT

David Shaffer-Gottschalk

Congratulations to composer William Averitt of Winchester. He has been selected to receive the commission for a new work in the 2012–2013 Virginia Music Teachers Association/Music Teachers National Association Composer Commissioning Program. Judges for the competition were Richard Schwartz of Colonial Heights, Harvey Stokes of Hampton, Samuel Wellman of Lynchburg, and John Winsor of Virginia Beach. Dr. Averitt's new composition will receive its premiere at the 2014 VMTA Conference.



William Averitt (b. 1948) is the composer of numerous works that have received performances throughout the United States and in Western Europe, Russia, and Asia. He has received numerous composer fellowships, grants and commissions from a wide variety of sources including the National Endowment for the Arts (twice), VMTA/MTNA (five times), the Hans Kindler

Foundation of the Library of Congress, Choral Arts of Seattle (3 scores premiered in2009, 2011, and 2013), Texas Lutheran University (3 scores premiered in 2012), the Maryland Symphony Orchestra, the Bach choir of Pittsburg, Opus 3 Trio of Washington, DC, Murray State University concert Choir, organist Dudley Oakes and Shenandoah Conservatory Chamber Choir. Other works include a two-hour *St. Matthew Passion* co-commissioned by eleven southeastern university choral departments and performed in 2010 at the Southern Division-ACDA Conference in Memphis.

Mr. Averitt's 1991 score Afro-American Fragments (Langston Hughes) for SATB, soprano and piano 4-hands was the winning work of the 1992 Roger Wagner Center for Choral Studies Choral Composition Competition. In 2004, Conspirare released three movements of Afro-American Fragments as part of their acclaimed CD ... through the green fuse... more recently, Mr. Averitt has written two similarly scored cycles on Langston Hughes' poetry: The Dream Keeper (Choral Arts of Seattle, 2009 and included on their award-winning CD Mornings Like This) and The Deepness of the Blue (Texas Lutheran University, 2012). His LC commission, Tripartita for violin, clarinet, and piano, was performed widely and recorded by the Verdehr Trio for Crystal Recordings. Tunebook for woodwind quintet won the 2012 National Flute Association Newly Published Music award for Chamber Music.

His works have been published by E.C. Schirmer, Treble Clef Press, Falls House Press, Little Piper, Fred Bock Music, ALRY Publications, Michigan State University Press, Concordia and MMB Publications. His music has been the subject of two doctoral treatises. Dr. Averitt is Professor Emeritus of Music and formerly Coordinator of Composition at Shenandoah Conservatory of Shenandoah University in Winchester, VA, where he was on the faculty from 1973 to 2012. ■

FALL FESTIVAL

It's time again for the Fall Festival! Encouraging your students to participate is a great way to get them off to a fast start this fall. In Northern Virginia, the festival will take place Saturday, November 2, 2013. At Richmond, Saturday, November 16, 2013 is the date for the festival. In Roanoke and Shenandoah, the festival will take place Saturday, November 23, 2013. The date of the festival is still to be announced for Lynchburg. See below for the registration postmark deadline and chair-

man for each location. No late applications will be accepted.

You may enter students in piano, piano duet, organ, strings, woodwinds, brass, percussion, classical guitar, accordion, or voice. Students must play one piece from the Contemporary Period containing at least one contemporary idiom. The second piece must be chosen from any historical period other than the Contemporary Period. In certain localities, pieces which are traditionally composed (perhaps from a method book) are accepted for the non-Contemporary piece, but only for beginning students. Please check with your local Fall Festival Chairman concerning this. Both pieces must be memorized. There are only two exceptions to this rule: 1) students in Levels III or IV who play an avant garde piece may use their music if this has been cleared by the local chairman prior to the registration deadline or 2) entries in piano duet or organ. No photocopied music is allowed. Only originally composed music is accepted, no simplifications or popular music.

Check the VMTA Yearbook under "General Regulations for All VMTA Events" and "VMTA Fall Festivals," for further information and regulations.
