MINUTES

VMTA GENERAL BUSINESS MEETING July 19, 2014, WINTERGREEN, VA

Larua Cardin, VMTA Secretary

President Paulo Steinberg called the meeting to order at 8:35 a.m.

Agenda amended to change bylaws wording. Betty Ann Spiers moves that Article 12 of the bylaws to be changed to read "the current edition of Roberts Rules of Order" seconded and approved.

Minutes from July 13, 2013 Conference at Wintergreen Resort, VA were approved as recorded.

Officers Reports:

President - Paulo Steinberg:

- Thank you Susan Atkins for an amazing conference. The 50th anniversary celebration is turning out great. We are proud of the partnership with Wintergreen Performing Arts.
- Recognition of the Chapter of the Year, Richmond MTA.
- There is a new collegiate chapter, Liberty University at Lynchburg, VA. This year we have a session for the collegiate members. There are other collegiate chapters represented this weekend as well, VCU and JMU.
- Paulo was at the MTNA conference in Chicago. It was great to have many members of VMTA in attendance. Paulo is pleased that we have great representation at the National Conference having teachers with National Competition winners.
- Please communicate with Paulo if you have any concerns or comments on things that are going well.

President Elect - Susan Atkins:

- Over 80 in attendance and 73 members have checked in so far. More attendees will be coming today from the collegiate chapter
- There will be a survey handed out later. President-Elect is happy with the location and enjoys working with the Wintergreen Performing Arts Festival.

VP Membership - Becky Wallenborn:

Our 2013–2014 membership closed with a total of 690 active, 152 senior, 28 student members; totaling 870. This is a decrease of 4 members from the previous year. As of June 30, 2014, we have 448 active, 145 senior and 14 student members (11 are High School age and 3 are Collegiate); totaling of 607. MTNA encourages us to continue to promote collegiate student membership as well as reviewing our own individual chapter strategies for increasing participation.

Secretary – Laura Cardin: Happy to be serving as Secretary. Nothing to report.

Treasurer – Mun Lee Han:

- As of June 30, 2014 Balance in Checking Account: \$29,938.37; Savings Account: \$22,025.56; CD: \$4,248.93.
- 3 Reminders the Treasurer needs:
 - 1. Reimbursement income and expenses need to be completed before June 30th every year.
 - 2. If you are requesting a check for more than \$600, we need a W-9 before the check can be written.
 - When you send a check, please include a memo or note saying what the check is for.
- The Executive Board recommends we approve the new budget for 2014. Voted and approved.

Certification – Lisa Moxley is moving out of Virginia and the new chair will be: Diane Perett, from Northern VA. Report from Lisa Moxley

- In March 856; 107 certified, 12.5% certified; 4 new certified teachers: Ruta Smedina Starke, Elizabeth Blakeslee, Richard James Masters and Ann Katherine Lee. Pins presented to present members by Paulo.
- There was a session about certification yesterday at the conference, led by Gabriella Ryan and Jeanette Winsor.
- Gabriella Ryan is willing to come to local chapters and talk in depth about certification.

Local Associations – Donna Halleck

- Yesterday, Presidents and representatives from the 12 local chapters met to share with the other Presidents, their plans and programs for events. New ideas were shared, including: converting the yearbooks, newsletters and documents to digital format.
- Unanimously, the main concern of each President is to increase membership by finding new ways to recruit new members. The consensus was—recruiting younger members may help to preserve the organization for the future. We welcome input from other members for solutions to this issue.

IMTF – Samantha Luck

- Beth Tomassetti will be running the IMTF forum today, talking about marketing private studios.
- This part of VMTA [IMTF] is to help you with guidance on how or what to do with your own studio, and to help promote a better quality of teaching. She has a list for local associations of programs that can be offered; email her for that information.
- Samantha has also been working as the Advertisement Chair. She has been updating the list of advertisers.

Old Business:

- **A.** Theory tests Tonya Menard and the committee are working on the second year of updating the theory tests. These should be available October or November at the latest.
- **B.** State Grant Paulo wrote a grant and it was declined. If there are any grants you know of that we can apply for, please let him know.

C. MTNA Federal Trade Commission (FTC) Investigation on Ethics

- Hand out the Antitrust Compliance Guide Summary at each meeting. Please read over the summary carefully. [See back page.] The presenters of workshops need to sign an agreement stating that they cannot discuss certain items that are on the summary.
- · Betty Ann Spiers read a letter from Gary Ingle, this was posted on the Professional Piano Teachers Facebook. Summary -Immediate and absolute clarity is not possible in one attempt. The FTC prohibited topics are not specific to MTNA. These apply to any group of competitors, regardless of business or industry. The FTC discourages anticompetitive conduct. The Antitrust Compliance Guide was developed for MTNA Affiliates and it is designed to protect the group from potential legal action related to antitrust laws, it is not intended to be a document to guide the actions of individual teachers. It is better for MTNA to be overly cautious and technical in our advice on the compliance guide.
 - At group events, we are not to discuss certain topics.
 - If you are sharing studio rates, etc., figures must be at least 3 months old.
 - More discussion held.
- If you have questions, contact Gary Ingle or Betty Ann Spiers.

New Business

- **A.** MusicLink The Executive Board approved an increase in fee from \$500 to \$700; this is already in the budget.
- **B.** Historian: Michele Carragan The VMTA Scrapbooks and some *NewsNotes* have been scanned.
- Our scrapbooks should be held and preserved in a better place. UVA is willing to hold the documents and would be Intellectual Property of UVA. We will be able to look at the items at UVA, but we will not be able to take the documents out of the library. Melissa Marrion moves that we hold the scrapbooks at UVA, seconded and approved.
- If anyone has documents or pictures, please hand them in or email them to the Michele. She only has scrapbooks up to 2004.

FALL FESTIVAL

It's time again for the Fall Festival! Encouraging your students to participate is a great way to get them off to a fast start this fall. In

Northern Virginia, the festival will take place Saturday, November 8, 2014. At Lynchburg, the date of the festival is tentatively set as Saturday, November 15, 2014. In Richmond, Roanoke, and Winchester (Shenandoah), the festival will take place Saturday, November 22, 2014. See below for the registration postmark deadline and chairman for each loca-

tion in addition to exact festival location. No late applications will be accepted.

You may enter students in piano, piano duet, organ, strings, woodwinds, brass, percussion, classical guitar, accordion, or voice. Students must play one piece from the Contemporary Period containing at least one contemporary idiom. The second piece must be chosen from any historical period other than the Contemporary Period. In certain localities, pieces which are traditionally composed (perhaps from a method book) are accepted for the non-Contemporary piece, but only for beginning students. Please check with your local Fall Festival Chairman concerning this. Both pieces must be memorized. There are only two exceptions to this rule: 1) students in Levels III or IV who play an avant garde piece may use their music if this has been

cleared by the local chairman prior to the registration deadline or 2) entries in piano duet or organ. No photocopied music is allowed. Only originally composed music is accepted, no simplifications or popular music.

Check the VMTA Yearbook under "General Regulations for All VMTA Events" and "VMTA Fall Festivals," for further information and regulations. Also check page 3 of the VMTA Yearbook for the contact information of each chairman.

Festivals will be held in the following locations with these registration postmark deadlines and local chairmen:

Lynchburg (CVMTA): To Be Announced; F. Johnson Scott, President.

Northern Virginia: October 6; Lori Santos, Virginia Moore and Miyon (Amy) Park, Chairmen; held at Cherrydale United Methodist Church, 3701 Lorcom Lane, Arlington, VA 22207.

Richmond: October 20; Lynn Redford and Deborah Martin, Chairmen; held at the University of Richmond, Booker Hall.

Roanoke: October 10; Peggy Schaaf and Bittsy Hall, Chairmen; held at Hollins University, Roanoke.

Winchester (Shenandoah): November 10; Dr. Sue Boyd, Chairman; held at Shenandoah University, Goodson Recital Hall. ■





Certification Profile: Ruta Smedina-Starke

free are so many ways to achieve great results in piano pedagogy. Every teacher has to choose his or her own approach. I always treat my students with kindness. I can be strict and demanding within reason but I never forget that only believing in someone will bring out the best results. I don't ever forget to find at least one positive

thing a student did during the lesson and recognize it. Maintaining a positive attitude is so important for a student not to lose interest in the piano and music in general."

In the fifteen years since she emigrated to the U.S. from Latvia, Ruta Smedina-Starke has developed a thriving studio of preparatory and college students. "I am lucky to have hardworking and dedicated students. They are willing to give their best in order to become the best they possibly can under my guidance. For the majority of my students the piano is one of the main after-school activities. I usually recommend no more than two other after-school activities in addition to the piano."

Ruta Smedina-Starke studied piano with Larisa Olshtinskaja at Yelgava City Music College. She graduated from the University of Latvia in Riga with a Bachelor of Arts in English. She then moved to Richmond, where she studied with Dr. Sonia Vlahcevic and earned a Master of Music in Piano Performance at VCU. She has studied privately with Dr. Dmitri Shteinberg for three years. Smedina-Starke is a member of Pi Kappa Lambda music honor society. "I always talk to my students and try to notice what kind of music they like. I allow them to choose at least one piece that they really love. As a rule one gets the best results practicing something they really love. I am always demanding about technique: scales, Hanon, Czerny. I think there is no such thing as 'no time for technique."

As a member of the Richmond Music Teachers Association, Smedina-Starke has served as Chair of the Bach Competition. She has been adjudicator for the Richmond Symphony Concerto Competition, the Charlottesville Music Teachers Association Concerto Competition, and the MTNA State Competition during the 2012 VMTA State Conference.

Winner of Jordan Kitts' 2006 Educator Award, Smedina-Starke currently is an adjunct faculty member at the VCU Department of Music. Her lecture recitals have included "Carl Maria von Weber and the Konzertstück for Piano, Op. 79," "Peter Ilyich Tchaikovsky and The Seasons for the Piano, Op 37b," and "Robert Schumann's Scenes from Childhood, Op. 15." She has performed in masterclasses of Stephen Hough, Jon Nakamatsu, Harold Martina and Seymour Bernstein.

"I believe in an individual approach to every student. A teacher should never blame a student for a passage that doesn't work—there is always a way that works and it is up to the teacher to find the right way to communicate it to the student even if it means explaining the same problem in a dozen different ways."

"Finally, I think a teacher never should stop learning and be open to new approaches and new repertoire." ■

C. Concerto Competition – New chair, Anna Ouspenskaya

 Wanda Hall recommends that the following sentence be added to be Concerto Competition Guidelines on page 13.

Following the sentence that reads, "No photocopy of copyrighted music may be used by the contestant, judges, or accompanists,"

This was rejected by the Executive Board. The Executive Board recommends using the wording from the MTNA website to be added to the VMTA guidelines.

- All entrants and accompanists must abide by the federal Copyright Law. Photocopies are strongly discouraged. Entrants using photocopies or PDFs downloaded from the Internet may be asked to complete the Music Release Form verifying that they have permission to use this music.
- All scores must be submitted to competition officials prior to the entrant's performance.
 - Measures must be numbered at the beginning of each system.
 - A Music Release Form must be signed for any photocopies being used.

ANTITRUST COMPLIANCE GUIDE SUMMARY

Topics which should not be discussed among members of state and local music teacher associations (but OK between an employer and employees in a studio):

- Current prices or hourly rates;
- Current billing policies and procedures;
- What constitutes fair profit margins;
- Plans to increase or decrease prices or hourly rates;
- Agreements to allocate or divide territories or clients;
- Policies regarding vacation time and missed lessons;
- Terms and conditions of sales such as late charges, prompt payment discounts, credit terms:
- Recommendations to members to implement unlawful tying arrangements such as requiring students to purchase sheet music exclusively from the teacher;
- Salaries of music studio employees;
- Complaints about or problems presented by other competitors or suppliers;
- Encouraging others to take retaliatory actions against competitors or suppliers, such as a boycott against a supplier that decided to offer music instruction in competition with members; and
- Efforts to influence suppliers' prices.

We can no longer share our studio policies with other members in meetings. General discus-

sions of past pricing levels or economic trends in the profession, as well as studio management, are fine as long as members do not share their own methods and experiences or try to influence other members in a certain direction.

Surveys of prices or hourly rates can only be taken by an independent third party, and the data collected must be at least three months old.

How to Guard Against Antitrust Liability

- Agendas for meetings should be prepared and distributed to attendees in advance of the meeting. A vote must be taken (after possible additions or subtractions from the agenda) to approve the "orders of the day." Once approved, the agenda cannot be changed except by a two-thirds majority vote.
- The written antitrust policy for the chapter (or state organization) should be distributed with the agenda at every meeting.
- Presenters for seminars and workshops should sign a written agreement in which they acknowledge and agree not to discuss any of the prohibited topics.
- An employee or member should be designated to serve as an antitrust compliance officer at each meeting. His or her primary responsibility is to cut off any discussions that drift into prohibited topics. The Parliamentarian would be a logical person to serve in this position.
- On-line sites should post rules about the prohibitions and be monitored by a volunteer who takes down inappropriate postings. (Webmaster)

It is important to publicize requirements for maintaining association membership.

Code of Ethics

A Code of Ethics must not impose any anti-competitive restrictions on members. Teachers cannot be restricted from recruiting students. A teacher referral service should be open to all members who sign up for the referral service. The association may charge a fee for this service. The service may list contact information} but should not list prices charged by teachers. Referrals should be made in an objective manner without favoritism.

Competitions and Festivals

Since competitions affect a teacher's ability to compete in the community, competitions should not be restricted to members only. Student competitions should be open to nonmembers. Non-members may be charged higher fees, but not so high that it effectively compels a teacher to join the organization. Limitations in the number of students accepted may be made because of practical conditions such as half size of the number of judges.

The conduct of judges in a competition is a recognized exemption to the antitrust restrictions; a judge may be restricted from soliciting students. A code of conduct for judges may be imposed that limits their criticism of students and teachers in the competition.

Non-competitive festivals can be restricted to students of members since this type of event does not greatly affect the teacher's competitiveness in the community.

All affiliates of the Music Teachers National Association must comply with these guidelines and be responsible for informing all members of restrictions and policies.
